Sir/Madam,

In continuation of this office letter No.F.1-1(31)/77/442, dated 4.2.80, it is to inform you that the Director of Education, Delhi, has been pleased to treat recognition of your school (Without aid) from class I to XII as 'absolute' However, the Management of the school is required to fulfil the following conditions/statutory requirements:-

- (i) Provisions of Delhi School Education Act & Rules, 1973 should be complied with strictly.
- (ii) It may be ensured that the requirements governing recognition as laid down under Section 4(1)(a) to (f) of Delhi School Education Act, 1973, conditions prescribed under rules 50 and facilities specified under rule 51 of Delhi School Education Rules, 1973 are properly complied with and provided
- (iii) Services of overaged and unqualified staff be regularised through Directorate of Education and those employees where it is not possible to do so be replaced by other qualified staff with prescribed age limit.
- (iv) Only qualified staff with prescribed age should only be appointed.
- (v) Salary to staff be paid well in time.
- (vi) Admission to the school shall be open to all without any discrimination on religion, caste and place of birth.
- (vii) The school shall not run for the profit to any individual or any other group/society.
- (viii) Adequate funds to meet the financial responsibilities and adequate sanitary conditions be ensured in the school.
